The Sicilian Festival is held each year in the heart of Little Italy to celebrate the cultural heritage of San Diego's Sicilian American Community.

APPLICATION DEADLINE: Food Vendors by **April 20, 2012** and Merchants by **May 10, 2012** . Applications must be accompanied by a check or money order. A \$50 late fee will be imposed on applications submitted after the deadline.

APPLICATION PRIORITY: Space assignments and priority system are based on deadlines, time stamp and participating past festivals.

SPACES: There will be no electricity, canopies, tables or chairs provided. **SPACE ONLY. NOTE EXCEPTION:** Authors displaying /selling books in the Sicilian Cultural Pavilion will be provided one table and two chairs per entry fee.

HOURS/SCHEDULE: The festival hours are from 10:00AM to 6:00PM. Check-in time is 6:00AM to 8:00AM. Booth locations are assigned at check-in. Space is forfeited if not occupied by 8:30AM.

PARKING: All vehicles must be removed from the festival area by 8:30AM. There is no vendor parking provided by the Festival. There is free parking available in the North Lot of the County Administration Building at 1600 Pacific Highway, San Diego, CA 92101

PERMITS AND CERTIFICATES: Food Vendors are responsible for San Diego County health permits. All permits must be posted within the booth. The Fire Marshall requires certified fire extinguishers in all food booths.

CONFIRMATIONS/REFUNDS: Confirmations will be mailed by May 1, 2012. No refunds in case of inclement weather, acts of nature or restrictions by government agencies to cancel the event, over which the *Sicilian Festival* has no control, will be given.
